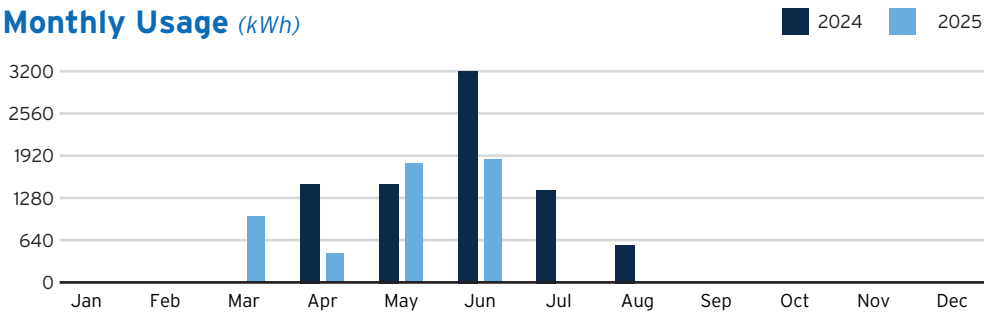

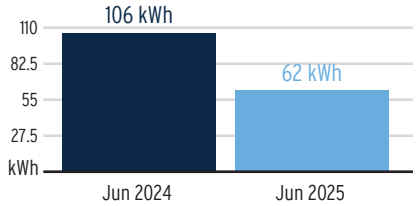

Technical Graphics and Analysis (TGA) is pleased to provide this proposal for water level logger battery replacement at Pond 9-5 at the Driftwood Village in the Live Oak Preserve development.

Background

Water levels are being recorded to calculate the effect of the pond sealing from the soil flocculant application in August 2022. The three water level loggers have been operational since May 2018, when they were installed to collect initial background data. These pressure transducer devices have internal batteries that have reached the end of their life. The Upper Floridan Aquifer logger was noticed to have a battery failure during the most recent quarterly data download session. The other two loggers in the Surficial Aquifer and Pond are expected to also have battery failure around the same time.

Approach

The cost of a new model replacement is \$544 compared to the refurbishment price of \$242 per unit. To continue collecting data, the existing loggers will be serviced by the manufacturer and then reinstalled by TGA in the field. An effort will be made to recover the data on the Upper Floridan logger that has lost power. Recalibration of the pressure sensor is required after battery replacement.

Task 1 Retrieval of the Loggers for Refurbishment

To save costs, the loggers will be removed from the field during the scheduled Q4 field data collection event. They will then be sent to Solinst Canada Ltd. for service.



Task 2 Reinstallation of Data Loggers

Once the equipment is returned from Solinst, a special site visit will be made to reinstall the loggers as soon as possible to minimize disruption of the data collection records.

Budget

The total cost is \$1,223.50

Task 1 Retrieval of the Loggers for Refurbishment

\$490 Will be invoiced for the routine Q4 site visit and data processing that is already in contract and is not included in this proposal. That event will be used to retrieve the loggers and send them in to Solinst.

These are the additional costs to ship the loggers and the proposed fees from Solinst:

- \$100 Shipping – includes both sending and receiving
- \$47.50 data extraction for the Upper Floridan logger (1 logger)
- \$72 for each battery replacement (3 loggers)
- \$170 for each sensor calibration after battery replacement. (3 loggers)

TASK 1 TOTAL = \$873.50

Task 2 Reinstallation of Data Loggers

Once the loggers are returned, a separate field visit will be made to reinstall and program the loggers at the site.

TASK 2 TOTAL = \$350
